ORDINANCE NO. 4077

AN ORDINANCE relating to the annexation of an area known as Laguna Hills to King County Water District No. 105.

## STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Laguna Hills to King County Water District No. 105 was filed with the County Council effective September 12, 1978.

2. King County Water District No. 105 has found the petition for annexation to be sufficient and has, by Resolution 593, concurred with the proposed annexation.

3. King County Water District No. 105 filed a Declaration of Nonsignificant Impact dated August 1, 1978 on the proposed annexation.

4. The County Council held a public hearing on December 4, 1978 and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 105 of the area known as Laguna Hills and described in Section 2 herein is approved.

SECTION 2. The area known as Laguna Hills to be annexed is described as follows:

The North  $\frac{1}{2}$  of the N.E.  $\frac{1}{4}$  of Section 14, Township 21N, Range 5 EWM,

Together with

The South  $\frac{1}{2}$  of the S.E.  $\frac{1}{4}$  of Section 11, Township 21N, Range 5 EWM.

Together with

The East  $\frac{1}{2}$  of the East  $\frac{1}{2}$  of the North  $\frac{1}{2}$  of the S.E.  $\frac{1}{4}$  of said Section 11

Together with

The N.W.  $\frac{1}{4}$  of the S.W.  $\frac{1}{4}$  of Section 12, Township 21N, Range 5 EWM.

Together with

The N.W.  $\frac{1}{4}$  of the N.E.  $\frac{1}{4}$  of the S.W.  $\frac{1}{4}$  of said Section 12
