AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Helen R. Harrington, Building and Land Development Division File No. 287-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Helen R. Harrington petitioned on May 24, 1978, SECTION 1.

that the property described in Section 3 below be reclassified from RS 7200 (Potential RM 2400) to RM 2400 and this application was assigned Building and Land Development Division File No. 287-78-R.

The report and recommendation of the Building and SECTION 2. Land Development Division was transmitted to the Zoning and Subdivision Examiner on September 21, 1978, and hearing was held by the Examiner on the matter September 28, 1978.
