ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Nina M. Collier, Building and Land Development Division File No. 303-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Nina M. Collier petitioned on September 1, 1978, SECTION 1. that the property described in Section 3 below be reclassified from SR and BN-P to RD 3600 and this application was assigned Building and Land Development Division File No. 303-78-R.

The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on November 2, 1978, and hearing was held by the Examiner on the matter November 9, 1978. The report of the Examiner was filed with the Clerk of the King County Council on November 30, 1978, and the Council approved the reclassification by Motion No. 03881 on December 4, 1978.
