ORDINANCE NO. 4101

AN ORDINANCE relating to the annexation of an area known as Herold to King County Water District No. 19.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Herold to King County Water District No. 19 was filed with the County Council effective December 11, 1978.
- 2. King County Water District No. 19 has found the petition for annexation to be sufficient and has, by Resolution 385, concurred with the proposed annexation.
- 3. King County Water District No. 19 filed a Declaration of Nonsignificant Impact dated June 9, 1978, on the proposed annexation.
- 4. The County Council held a public hearing on the 15th day of January, 1979, and has considered the criteria set forth in RCW 57.01.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 19 of the area known as Herold and described in Section 2 herein is approved.
