ORDINANCE NO. 4140

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Joseph H. Jobe, Building and Land Development Division File No. 150-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Joseph H. Jobe petitioned on March 6, 1978, that the property described in Section 3 below be reclassified from SE to SR and this application was assigned Building and Land Development Division File No. 150-78-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on May 4, 1978, and hearing was held by the Examiner on the matter May 11, 1978 and October 3, 1978. The report of the Examiner was filed with the Clerk of the King County Council on November 27, 1978, and the Council approved the reclassification by Motion No. 03880 on December 4, 1978, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassi-

OVERALL LEGAL DESCRIPTION:

That portion of the Northwest 1/4 of Section 13-25-5, lying Northeasterly of S.R. No. 901, West Lake Sammamish Parkway N.E.; lying Southwesterly of Sammamish River as shown on Plan 19 (Sheet 20 of 60) U.S. Army Engineer, approved 4-30-63; lying Northerly of Redmond Ordinance No. 794 and lying Southerly of the following described line: beginning at a point on the center line of said S.R. No. 901, said point being 873' North and South 88°46'42" East 677.34' from the West 1/4 corner of said Section 13-25-5, thence South 88°46'42" East 12.31'; thence, North 59°11'08" East 20.12' to the Northeasterly margin of said S.R. No. 901 and the point of beginning of said line to be described; thence continuing North 59°11'08" East to the left bank of said Sammamish River and and terminus of said line. Less that portion described as follows: beginning at a point on said center line of said S.R. No. 901 said point being 442.50' North and 947' East of said West 1/4 corner; thence North 77°22' East to the Northeasterly margin of said S.R. No. 901 and the true point of beginning (T.P.O.B.); thence Northwesterly along said Northeasterly margin 220'+; thence North 77°22' East 150'+; thence Southeasterly margin of S.R. No. 901 to point which is North 77°22' East 150'+ from the T.P.O.B.; thence South 77°22' West 150'+ to the T.P.O.B.
