

ORDINANCE NO. 4205

AN ORDINANCE approving the Sewer General Comprehensive Plan for the Northeast Lake Washington Sewer District, amending Ordinance 4147.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 4147, Section 1 is hereby amended to read as follows: The Northeast Lake Washington Sewer Comprehensive Facilities Plan (March, 1977, attached as Exhibit A to Ordinance 4147, is hereby approved, subject to the following conditions:

Those areas in the Swamp Creek Basin which are designated residential at one dwelling unit per acre in the Northshore Communities Plan and those areas along the north bank of the Sammamish River, south of Bothell Way and lying between approximately 75th Avenue N.E. (if extended) and 92nd Place N.E. (if extended) which are designated residential at one dwelling unit per acre and open space by the Northshores Communities Plan shall be subject to the following policy statement adopted as part of the Sewerage General Plan:

"Sewer service to these areas shall be consistent with the density guidelines of the Sewerage General Plan and the Northshore Community Plan, provided that the district or municipality will not approve a ULID or extend service until King County Council adopts the revised Northshore Community Plan or January 1, 1980, whichever comes first."

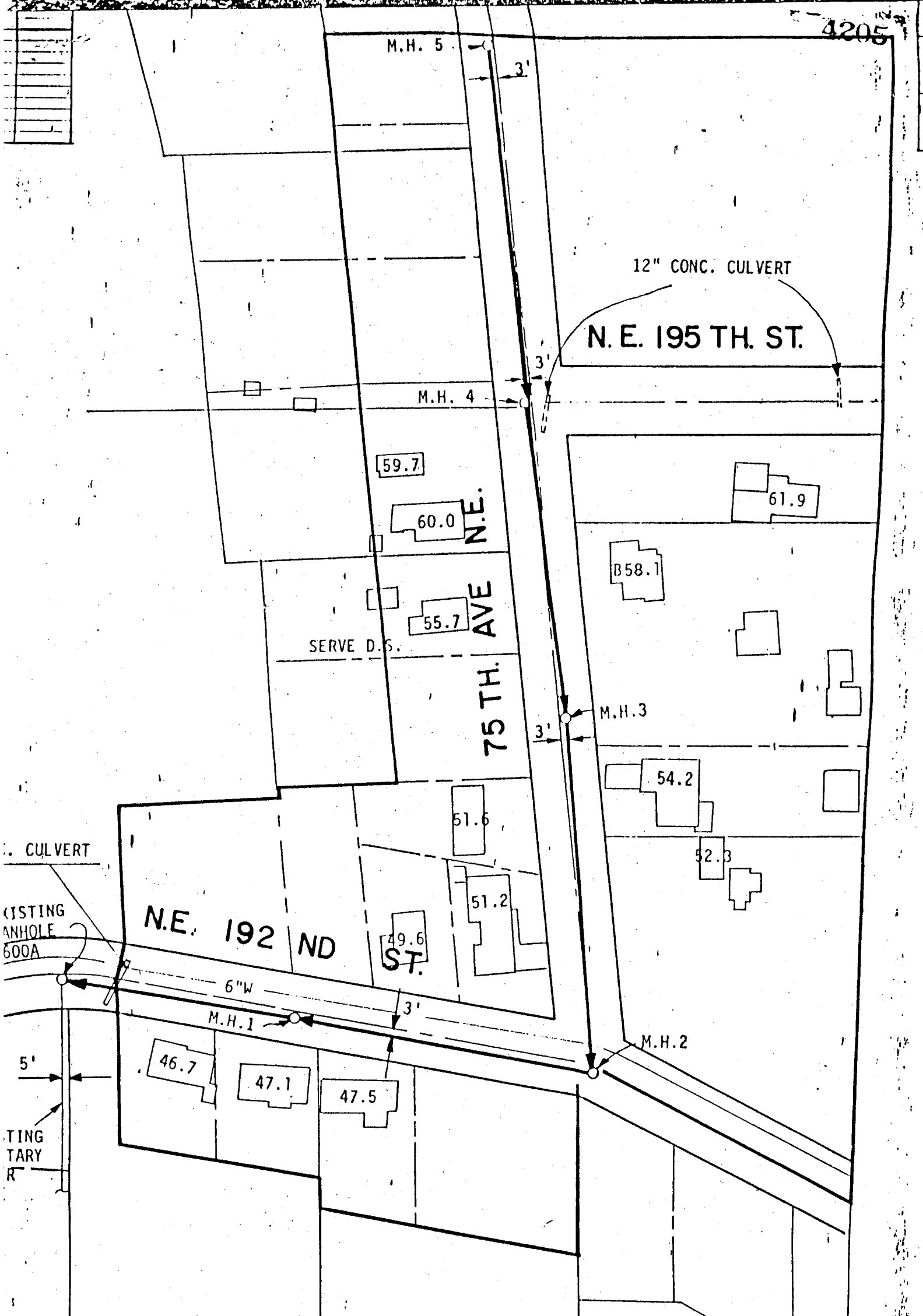
