ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Grace D. Adams, Building and Land Development Division File No. 223-77-R(A).

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Grace D. Adams petitioned on February 23, 1977, that the property described in Section 3 below be reclassified from RM 2400-P to RS 7200 (Potential RM 1800) and this application was assigned Building and Land Development Division File No. 223-77-R(A).

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on September 14, 1978, and hearing was held by the Examiner on the matter September 28, 1978. The report of the Examiner was filed with the Clerk of the King County Council on November 2, 1978, and the Council approved the reclassification by Motion No. 03828 on November 6, 1978.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
