The Division of Building and Land Development has studied the proposed alley vacation and finds that it would not be in conflict with the principles and purposes of the King County Comprehensive Plan and the specific plans in the vicinity of this proposed vacation.

- The vacation area, containing 2,700 square feet, was obtained as a portion of the Plat of Fall City, recorded August 23, 1907. A search of the records indicates that the alley has never been improved or maintained by the County. Therefore, the right of way is classified "C Class" in accordance with Ordinance No. 2759.
- The Department of Public Works considers the subject vacation area useless as part of the County road system and believes that the public would be benefited by the return of this unused area to the public tax rolls.

Due notice was given in the manner provided by law and a hearing was held by the King County Council on the 14th day of 11/au

In consideration of the benefits to be derived from the subject vacation, the Council has determined that it is in the best interest of the citizens of King County to grant said petition.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Council on the 14th day of //(au) hereby vacates and abandons the portion of an alley in Fall City, Washington, described as follows:
