ORDINANCE NO. 4261

AN ORDINANCE relating to the vacation of a portion of alley in Plat of Baring
Petitioner: Stephen M. Maxwell and others

STATEMENT OF FACTS

- 1. A petition has been filed requesting vacation of a portion of an alley in the Plat of Baring, hereinafter described.
- 2. The Division of Building and Land Development has studied the proposed alley vacation and finds that it would not be in conflict with the principles and purposes of the King County Comprehensive Plan and the specific plans in the vicinity of this proposed vacation.
- 3. The Department of Public Works notified the various utilities serving the area and was advised that easements are not required.
- 4. The vacation area was obtained June 10, 1901, when the Plat of Baring was recorded. The Operations Division of the Department of Public Works has reported that there are no records which indicate the County ever expended funds for acquisition, construction or maintenance on the alley. Therefore, the right of way is classified "C Class" in accordance with King County Ordinance No. 2759.
- 5. The Department of Public Works considers the subject vacation area useless as part of the County road system and believes the public would be benefited by the return of this unused area to the public tax rolls.

Due notice was given in the manner provided by law and a hearing was held by the King County Council on the $\frac{14}{12}$ day of $\frac{19}{12}$, $\frac{19}{12}$

In consideration of the benefits to be derived from the subject vacation, the Council has determined that it is in the best interest of the citizens of King County to grant said petition.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
