

ORDINANCE NO. 4262

AN ORDINANCE appropriating a total of \$160,600 to several County funds to pay for the costs of unlevied Social Security taxes on sick leave for the period of January 1, 1976 through October 31, 1977, amending Ordinance No. 3969, Sections 43, 44, 49, 58, 62, 64 and 67, as amended, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$118,465 from the unappropriated Current Expense Fund balance to Special Programs for the purpose of paying unlevied 1976 and 1977 Social Security taxes on sick leave.

SECTION 2. Ordinance No. 3969, Section 43, as amended, is hereby amended as follows:

Special Programs ~~(\$4,272,098)~~ \$4,390,503

PROVIDED THAT:

The provisos adopted by the Council in Ordinance No. 3969 shall be fulfilled.

SECTION 3. There is hereby approved and adopted an appropriation of \$25,449 from the unappropriated Road Fund balance to the Road Fund for the purpose of paying unlevied 1976 and 1977 Social Security taxes on sick leave.

SECTION 4. Ordinance No. 3969, Section 44, is hereby amended as follows:

SECTION 5. There is hereby approved and adopted an appropriation of \$2,667 from the unappropriated Alcoholism Fund balance to the Alcoholism Fund for the purpose of paying unlevied 1976 and 1977 Social Security taxes on sick leave.

SECTION 6. Ordinance No. 3969, Section 49, is hereby amended as follows:

8 SECTION 9. There is hereby approved and adopted an appropria-
9 tion of \$3,613 from the unappropriated Systems Services Fund
10 balance to the Systems Services Fund for the purpose of paying
11 unlevied 1976 and 1977 Social Security taxes on sick leave.

12 SECTION 10. Ordinance No. 3969, Section 62, as amended, is
13 hereby amended as follows:

14 Systems Services ~~(\$5,544,353)~~ \$5,517,966

15 SECTION 11. There is hereby approved and adopted an appro-
16 priation of \$1,951 from the unappropriated Airport Fund balance to
17 the Airport fund for the purpose of paying unlevied 1976 and 1977
18 Social Security taxes on sick leave.

19 SECTION 12. Ordinance No. 3969, Section 64, as amended, is
20 hereby amended as follows:

21 Airport ~~(\$2,138,449)~~ \$2,140,400

22 SECTION 13. There is hereby approved and adopted an appro-
23 priation of \$5,562 from the unappropriated Solid Waste Fund balance
24 to the Solid Waste Fund for the purpose of paying unlevied 1976 and
25 1977 Social Security taxes on sick leave.

26 SECTION 14. Ordinance No. 3969, Section 67, is hereby amended
27 as follows:
