## ORDINANCE NO.

AN ORDINANCE making an appropriation of \$79,445 to the Federal Shared Revenue Fund from previously unappropriated 1978 Federal Shared Revenue Fund balance for the purpose of making an inter-fund transfer to support an additional appropriation of the same amount within Special Programs - Current Expense Fund and authorizing a reduction in the amount of \$20,555 in Executive Contingency - Current Expense Fund for the purpose of providing a \$100,000 social program to benefit the children of King County in observance of the International Year of the Child; amending Ordinance No. 3969, Sections 43 and 59, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. As delineated in Sections 2 and 3 of this ordinance, an appropriation of \$79,445 to the Federal Shared Revenue Fund from previously unappropriated 1978 Federal Shared Revenue Fund balance for the purpose of making an inter-fund transfer to support an additional appropriation of the same amount within Special Programs - Current Expense Fund and an authorization to reduce \$20,555 from Executive Contingency - Current Expense Fund for the purpose of providing a \$100,000 social program to benefit the children of King County in observance of the International Year of the Child is hereby approved and adopted

SECTION 2. Ordinance No. 3969, Section 59, as amended, is hereby amended as follows:

From the Federal Shared Revenue Fund balance, including interest, the following appropriation, for the purpose of making an inter-fund transfer to Special Programs - Current Expense Fund, to support various social program projects is hereby adopted:
