6 ORDINANCE NO. 4281

7 AN ORDINANCE amending King County Zoning Resolution
8 No. 25789, as amended, by amending the Zoning Map
9 thereof reclassifying certain property thereon at
the request of Pacific Gamble Robinson Company, et al,
Building and Land Development Division File No. 143-
77-R.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. Pacific Gamble Robinson Company, et al, petitioned
12 on May 6, 1977, that the property described in Section 3 below be
13 reclassified from RS 7200 (Potential RM 2400) to RM 900 and RM 2400
14 and this application was assigned Building and Land Development
15 Division File No. 143-77-R.

16 SECTION 2. The report and recommendation of the Building and
17 Land Development Division was transmitted to the Zoning and Sub-
18 division Examiner on July 5, 1977, and hearing was held by the
19 Examiner on the matter July 12, 1977 and July 26, 1977. The report
20 of the Examiner was filed with the Clerk of the King County Council
21 on August 18, 1977, and the Council approved the reclassification by
22 Motion No. 03170 on August 29, 1977.

23 SECTION 3. The legal description of the property to be re-
24 classified is attached as Appendix A and is hereby made a part of
25 this ordinance. The above described property is shown on the at-
26 tached map which is designated Appendix B and is hereby made a part
27 of this ordinance.

28 SECTION 4. The King County Council does hereby amend King
29 County Zoning Code, Resolution No. 25789, as amended, by reclassi-

1 fying that property described and shown in Section 3, Appendices
2 A and B above, to RM 2400 and directs that Area Map W 18-26-4 be
3 modified to so designate.

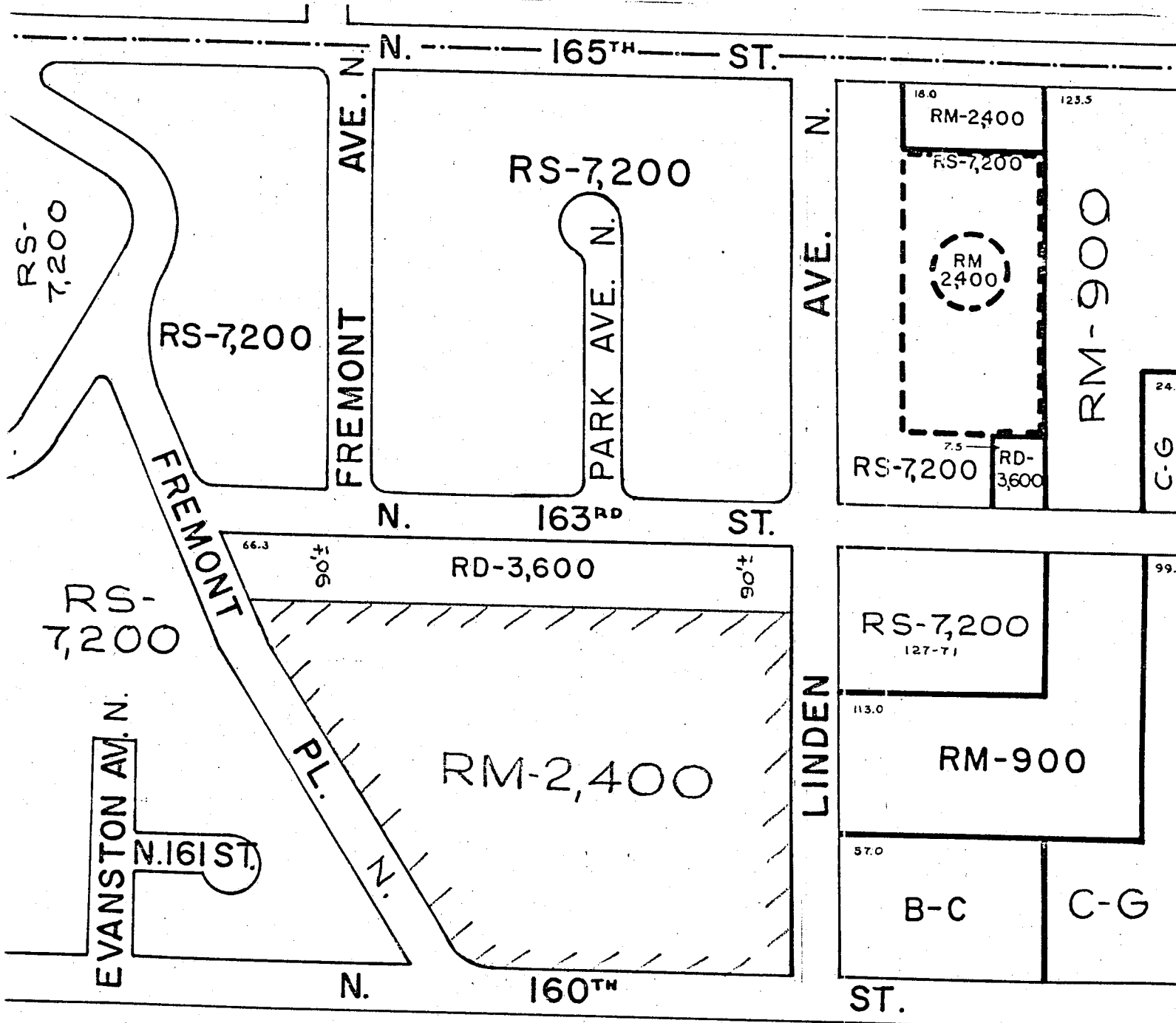
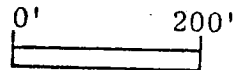
OVERALL LEGAL DESCRIPTION:
