7 ORDINANCE NO. 4284

8 AN ORDINANCE amending King County Zoning
9 Resolution No. 25789, as amended, by amending
10 the Zoning Map thereof reclassifying certain
11 property thereon at the request of Ethel Sharp,
Building and Land Development Division File
No. 291-78-R.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. Ethel Sharp petitioned on June 2, 1978, that the
14 property described in Section 3 below be reclassified from SR to
15 RM 900 and this application was assigned Building and Land Devel-
16 opment Division File No. 291-78-R.

17 SECTION 2. The report and recommendation of the Building
18 and Land Development Division was transmitted to the Zoning and
19 Subdivision Examiner on September 21, 1978, and hearing was held
20 by the Examiner on the matter September 28, 1978. The report of
21 the Examiner was filed with the Clerk of the King County Council
22 on November 27, 1978, and the Council approved the reclassifica-
23 tion by Motion No. 3878 on December 4, 1978, subject to conditions
24 which will be satisfied per the "P" suffix.

25 SECTION 3. The legal description of the property to be re-
26 classified is attached as Appendix A and is hereby made a part
27 of this ordinance. The above described property is shown on the
28 attached map which is designated Appendix B and is hereby made
29 a part of this ordinance.

30 SECTION 4. The King County Council does hereby amend King
31

1 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
2 fying that property described and shown in Section 3, Appendices
3 A and B above, to RM 900-P and directs that Area Map E 32-23-5
4 be modified to so designate.

5 SECTION 5. This reclassification is granted subject to condi-
6 tions adopted in Motion No. 3878 and said conditions are incor-
7 porated as though fully set forth herein.


