ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of H. Pete & Francis Thomas, Building and Land Development Division File No. 440-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. H. Pete & Francis Thomas petitioned on October 4, 1978, that the property described in Section 3 below be reclassified from SR & RM 1800 to RM 1800 and this application was assigned Building and Land Development Division File No. 440-78-R.

SECTION 2. The report and recommendation of the Euilding and Land Development Division was transmitted to the Zoning and Sub-18 division Examiner on December 7, 1978, and hearing was held by the Examiner on the matter December 14, 1978. The report of the Examiner was filed with the Clerk of the King County Council on February 8, 1979, and the Council approved the reclassification by 22 Motion No. 04019 on February 13, 1979, subject to conditions which will be satisfied per the "P" suffix.

The legal descripton of the property to be re-SECTION 3. classified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
