6 ORDINANCE NO. 4287

7 AN ORDINANCE amending King County Zoning Resolution
8 No. 25789, as amended, by amending the Zoning Map
9 thereof reclassifying certain property thereon at
the request of Carl O. Johnson, et ux, Building and
Land Development Division File No. 434-78-R.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. Carl O. Johnson, et ux, petitioned on September 25,
12 1978, that the property described in Section 3 below be reclassified
13 from RS 7200 (Potential RM 1800) and RS 7200 to RM 1800 and this
14 application was assigned Building and Land Development Division
15 File No. 434-78-R.

16 SECTION 2. The report and recommendation of the Building and
17 Land Development Division was transmitted to the Zoning and Sub-
18 division Examiner on December 7, 1978, and hearing was held by the
19 Examiner on the matter December 14, 1978. The report of the Exam-
20 iner was filed with the Clerk of the King County Council on
21 January 25, 1979, and the Council approved the reclassification by
22 Motion No. 03985 on January 29, 1979, subject to conditions which
23 will be satisfied per the "P" suffix.

24 SECTION 3. The legal description of the property to be re-
25 classified is attached as Appendix A and is hereby made a part of
26 this ordinance. The above described property is shown on the at-
27 tached map which is designated Appendix B and is hereby made a part
28 of this ordinance.

29 SECTION 4. The King County Council does hereby amend King
30 County Zoning Code, Resolution No. 25789, as amended, by reclassi-

1 fying that property described and shown in Section 3, Appendices
2 A and B above, to RM 1800-P and directs that Area Map W 18-23-4
3 be modified to so designate.

4 SECTION 5. This reclassification is granted subject to condi-
5 tions adopted in Motion No. 03985 and said conditions are incorpor-
6 ated herein as though fully set forth herein.


