ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Kit's Corner Investors, Building and Land Development Division File No. 212-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Kit's Corner Investors petitioned on December 5, 1978, that the property described in Section 3 below be reclassified from RM 900 to M-P-P and this application was assigned Building and Land Development Division File No. 212-79-R.

ECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on February 15, 1979, and hearing was held by the Examiner on the matter February 22, 1979. The report of the Examiner was filed with the Clerk of the King County Council on March 16, 1979, and the Council approved the reclassification by Motion No. 4112 on March 26, 1979.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
