AN ORDINANCE relating to the alteration of a portion . . of the Plat of Twin Lakes Shopping Center South V-1637 Petitioner: Twin Lakes Associates

## STATEMENT OF FACTS

- A petition has been filed requesting an alteration of the Plat of Twin Lakes Shopping Center South, hereinafter described
- The Department of Public Works notified the various utilities ser-2. ving the area and were advised that easements are not required.
- The Division of Building and Land Development has studied the subject proposed plat alteration and finds that it would not be in conflict with the principles and purposes of the King County Comprehensive Plan and the specific plans in the vicinity of this proposed alteration.
- The alteration is a drainage easement located in the Plat of Twin Lakes Shopping Center South. The owners of the land have granted a supplemental easement to accommodate a drainage facility. A search of the records indicates that the County has spent no funds for acquisition or maintenance of the easement. The vacation area is classified "C Class" in accordance with County Ordinance No. 2759.
- The Department of Public Works considers the subject easement use-5. less as part of the County drainage system and believes the Public would be benefited by the alteration of the Plat.

Due notice was given in the manner provided by law and a hearing was held by the King County Council on the 4th day of June, 1979.

In consideration of the benefits to be derived from the subject vacation, the Council has determined that it is in the best interests of the Citizens of King County to grant said petition.
