

ORDINANCE NO. 4348

AN ORDINANCE relating to alterations, creation, abolishment and division of precincts in King County and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Precincts are divided, boundaries of precincts are altered, and new precincts are established, as set forth in the attachment hereto.

SECTION 2. The County Council finds as a fact and declares that an emergency exists and that this ordinance is necessary for the immediate preservation of public peace, health or safety or for the support of county government and its existing public institutions.
