8 ORDINANCE NO. 4372

9 AN ORDINANCE amending King County Zoning Resolution
10 No. 25789, as amended, by amending the Zoning Map
11 thereof reclassifying certain property thereon at
the request of Allan Willman and Mary K. Nollan,
Building and Land Development Division File No.
104-78-R.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. Allan Willman and Mary K. Nollan petitioned on
14 October 17, 1977, that the property described in Section 3 below be
15 reclassified from SR to RM 900 and this application was assigned
16 Building and Land Development Division File No. 104-78-R.

17 SECTION 2. The report and recommendation of the Building and
18 Land Development Division was transmitted to the Zoning and Sub-
19 division Examiner on January 5, 1978, and hearing was held by the
20 Examiner on the matter January 12, 1978. The report of the Examiner
21 was filed with the Clerk of the King County Council on February 10,
22 1978, and the Council approved the reclassification by Motion No.
23 03390 on February 21, 1978, subject to conditions which will be
24 satisfied per the "P" suffix.

25 SECTION 3. The legal description of the property to be re-
26 classified is attached as Appendix A and is hereby made a part of
27 this ordinance. The above described property is shown on the at-
28 tached map which is designated Appendix B and is hereby made a part
29 of this ordinance.

1 SECTION 4. The King County Council does hereby amend King
2 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
3 fying that property described and shown in Section 3, Appendices A
4 and B above, to RM 2400-P and directs that Area Map E 28-26-5 be
5 modified to so designate.

6 SECTION 5. This reclassification is granted subject to condi-
7 tions adopted in Motion No. 03390 and said conditions are incor-
8 porated herein as though fully set forth herein.
