6 ORDINANCE NO. 4399

7 AN ORDINANCE amending King County Zoning Resolution  
8 No. 25789, as amended, by amending the Zoning Map  
9 thereof reclassifying certain property thereon at  
10 the request of Darlene Freese, Building and Land  
11 Development Division File No. 117-79-R.

11 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

12 SECTION 1. Darlene Freese petitioned on December 11, 1978,  
13 that the property described in Section 3 below be reclassified  
14 from SR to RM 1800 and this application was assigned Building  
15 and Land Development Division File No. 117-79-R.

16 SECTION 2. The report and recommendation of the Building  
17 and Land Development Division was transmitted to the Zoning and  
18 Subdivision Examiner on February 1, 1979, and hearing was held  
19 by the Examiner on the matter February 8, 1979. The report of  
20 the Examiner was filed with the Clerk of the King County Council  
21 on March 9, 1979, and the Council approved the reclassification  
22 by Motion No. 4089 on March 19, 1979, subject to conditions which  
23 will be satisfied per the "P" suffix.

24 SECTION 3. The legal description of the property to be re-  
25 classified is attached as Appendix A and is hereby made a part  
26 of this ordinance. The above described property is shown on the  
27 attached map which is designated Appendix B and is hereby made  
28 a part of this ordinance.

29 SECTION 4. The King County Council does hereby amend King  
30 County Zoning Code, Resolution No. 25789, as amended, by reclassi-  
31 fying that property described and shown in Section 3, Appendices

1 A and B above, to RM 1800-P and directs that Area Map W 29-26-5  
2 be modified to so designate.

3 SECTION 5. This reclassification is granted subject to condi-  
4 tions adopted in Motion No. 4089 and said conditions are incor-  
5 porated as though fully set forth herein.
