AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Russel F. Fournier, Building and Land Development Division File No. 266-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Russel F. Fournier petitioned on March 30, 1978, 13 that the property described in Section 3 below be reclassified from 14 SR (Potential RD 3600) to RD 3600 and this application was assigned 15 Building and Land Development Division File No. 266-78-R.
