ORDINANCE NO. 0004446

AN ORDINANCE relating to the annexation of an area known as Southwest 356th Street to Lakehaven Sewer District.

STATEMENT OF FACT:

- A notice of intention proposing the annexation of an area known as Southwest 356th Street to Lakehaven Sewer District was filed with the County Council effective July 16, 1979.
- Lakehaven Sewer District has found the petition for annexation to be sufficient and has, by Resolution 79-686, concurred with the proposed annexation.
- 3. Lakehaven Sewer District filed a Declaration of Nonsignificant Impact dated May 8, 1979, on the proposed annexation.
- The County Council held a public hearing on the _, $19'/\langle$, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Lakehaven Sewer District of the area known as Southwest 356th Street and described in Section 2 herein is approved.

SECTION 2. The area known as Southwest 356th Street to be annexed is described as follows:

Those portions of Section 25, Township 21 North, Range 3 East, W.M., Section 19, Township 21 North, Range 4 East, W.M. and Section 30, Township 21 North, Range 4 East, W.M. ALL in King County, Washington described as follows:

The Northeast quarter of the Northeast quarter of said Section 25;

TOGETHER WITH the South half of Government Lot 4 of said Section 19;

TOGETHER WITH that portion of said Section 30 described as follows:

Beginning at the Northwest corner of said Section 30; Thence Southerly along the West Line thereof to the South line of the Northwest quarter of the Northwest quarter of said Section 30 (also being the centerline of Southwest 356th Street - LIBO ROAD); Thence Easterly along the centerline of said Southwest 356th

Street - LIBO ROAD to the West line of the East half of the Northwest quarter of the Southwest quarter of the Northeast quarter of said Section 30; Thence Northerly along the said West line to the North line of the said Southwest quarter of the Northeast quarter of said Section 30; Thence Easterly along the said North line to the West line of the Southeast quarter of the Northwest quarter of the Northeast quarter of said Section 30; Thence Northerly along said West line to the North line of said Southeast quarter of the Northwest quarter of the Northeast quarter; Thence Easterly along said North line to the West line of the Northeast quarter of the Northeast quarter of said Section 30; Thence Northerly along said West line to the North line of said Section 30; Thence Westerly along said North line to the Northwest corner of said Section 30 and the point of beginning.
