9 ORDINANCE NO. 0004459

10 AN ORDINANCE amending King County Zoning  
11 Resolution No. 25789, as amended, by  
12 amending the Zoning Map thereof reclassi-  
13 fying certain property thereon at the  
14 request of Lakeside Village Rezone,  
Building and Land Development Division  
File No. 233-78-R.

15 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16 SECTION 1. Lakeside Village Rezone petitioned on January 11,  
17 1978, that the property described in Section 3 below be reclassi-  
18 fied from RS 7200 to RD 3600 and this application was assigned  
19 Building and Land Development Division File No. 233-78-R.

20 SECTION 2. The report and recommendation of the Building  
21 and Land Development Division was transmitted to the Zoning and  
22 Subdivision Examiner on April 13, 1978, and hearing was held by  
23 the Examiner on the matter April 20, 1978. The report of the  
24 Examiner was filed with the Clerk of the King County Council on  
25 July 5, 1978, and the Council approved the reclassification by  
26 Motion No. 3744 on September 25, 1978, subject to a Final P.U.D.  
27 which have now been satisfied.

28 SECTION 3. The legal description of the property to be re-  
29 classified is attached as Appendix A and is hereby made a part  
30 of this ordinance. The above described property is shown on the  
31 attached map which is designated Appendix B and is hereby made  
32 a part of this ordinance.

1            SECTION 4. The King County Council does hereby amend King  
2 County Zoning Code, Resolution No. 25789, as amended, by reclassi-  
3 fying that property described and shown in Section 3, Appendices  
4 A and B above, to RD 3600 and directs that Area Map E 8-21-4  
5 be modified to so designate.

6            SECTION 5. This reclassification is granted subject to condi-  
7 tions adopted in Motion No. 3744 and said conditions are incor-  
8 porated as though fully set forth herein.
