4 ORDINANCE NO. 0004482

5 AN ORDINANCE relating to the abandonment
6 of certain Forward Thrust arterial street
7 projects within the City of Kirkland and
8 the reallocation of these funds to other
9 projects, pursuant to King County Resolution
10 No. 34569, Section 6.

11 PREAMBLE:

12 The consolidated City of Kirkland has, on February 21,
13 1978, enacted Ordinance No. 2374 (hereto attached) and determined
14 that the following Forward Thrust arterial street projects
15 contained in King County Resolution No. 34569, Section 3, City
16 of Kirkland, and then existing City of Houghton have become
17 impractical to substantially accomplish:

- 18 P (4) 9th Avenue South from 6th Street South
19 to 10th Street South
20 (5) 10th Street South from 9th Avenue South
21 to Kirkland Way
22 (15) 18th Avenue from Market Street to
23 116th Avenue N.E.
24 (6) Kirkland Way from 10th Street South
25 to SSH-901
26 (13) 6th Street from 15th Avenue to N.E. 106th
27 Street
28 (14) 8th Street from 7th Avenue to N.E. 106th
29 Place
30 L (1) N.E. 60th Street from 108th Avenue N.E.
31 to 124th Avenue N.E.

32 The consolidated City of Kirkland having determined
33 by Ordinance No. 2374, Sections 1 and 2, that all projects which
it has been authorized to accomplish pursuant to King County
Resolution No. 34569 have been completed, or their completion
duly provided for, or their completion found to be impractical,
has determined that bond proceeds be applied to carry out the

1 following new public arterial highway improvements within the
2 territorial limits of the consolidated City of Kirkland:

3 Lakeview Drive - Lake Washington Boulevard to
4 State Street.

5 Resolution No. 34569, Section 6, requires that the
6 King County Legislative Authority determine that the proposed
7 additional projects are consistent with the purposes of Resolution
8 No. 34569, that is, arterial highway improvements, and are a
9 County purpose.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. Pursuant to Section 6 of Resolution No.
12 34569, the following project within the consolidated City
13 of Kirkland is determined to be consistent with the purposes
14 of the above Resolution and a County purpose:

15 Lakeview Drive - Lake Washington Boulevard
16 to State Street
