ORDINANCE NO. 0004484

AN ORDINANCE relating to the abandonment of certain Forward Thrust arterial street projects within the City of Mercer Island and the reallocation of these funds to other projects pursuant to King County Resolution No. 34569, Section 6.

PREAMBLE:

The City of Mercer Island has, on September 26, 1977, enacted Ordinance No. 436 (hereto attached) and determined that the following Forward Thrust arterial street projects contained in King County Resolution No. 34569, Section 3, City of Mercer Island, have become impractical to substantially accomplish:

- 78th Avenue S.E. S.E. 34th Street to West Mercer Way (duly provided for from S.E. 34th Street to S.E. 40th Street from S.E. 40th Street to West Mercer Way no longer classified as arterial)
 - S.E. 72nd Street West Mercer Way to (14)84th Avenue S.E.
 - Island Crest Way S.E. 68th Street to (16)80th Avenue S.E.
- S (4)North Mercer Way - 88th Avenue S.E. to 90th Avenue S.E.
 - 84th Avenue S.E. S.E. 24th Street to (5) North Mercer Way
 - North Mercer Way West Mercer Way to (7)S.E. 22nd Street
 - West Mercer Way I-90 to North Mercer (8) Way
- 76th Avenue S.E. from S.E. 24th Street \mathbf{T} (9)to S.E. 22nd Street
 - S.E. 22nd Street from North Mercer Way (10)to 86th Avenue S.E.

The City of Mercer Island, having determined by Ordinance No. 436, Sections 1 and 2, that all projects which it has been authorized to accomplish pursuant to King County

Resolution No. 34569 have been completed, or their completion duly provided for, or their completion found to be impractical, has determined that bond proceeds be applied to carry out the following new public arterial highway improvements within the territorial limits of Mercer Island:

- (1) S.E. 40th Street Island Crest Way to 92nd Avenue S.E.
- (2) 76th Avenue S.E. S.E. 24th Street to S.E. 28th Street
- (3) S.E. 27th Street 76th Avenue S.E. to 78th Avenue S.E.
- (4) 78th Avenue S.E. S.E. 27th Street to S.E. 34th Street
- (5) S.E. 28th Street 78th Avenue S.E. to Island Crest Way
- (6) S.E. 32nd Street 77th Avenue S.E. to 78th Avenue S.E.
- (7) 77th Avenue S.E. Sunset Highway to S.E. 32nd Street
- (8) S.E. 29th Street 76th Avenue S.E. to 78th Avenue S.E.
- (9) North Mercer Way 76th Avenue S.E. to S.E. 27th Street.

Resolution No. 34569, Section 6, requires that the King County Legislative Authority determine that the proposed additional projects are consistent with the purposes of Resolution No. 34569, that is, arterial highway improvements, and are a . County purpose.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pursuant to Section 6 of Resolution No. 34569, the following projects within the City of Mercer Island are determined to be consistent with the purposes of the above Resolution No. 34569 and a County purpose:

(1) S.E. 40th Street - Island Crest Way to 92nd Avenue S.E.
