AN ORDINANCE relating to the annexation of an area known as South 124th Street to Rainier  $\,$ Vista Sewer District.

## STATEMENT OF FACT:

- A notice of intention proposing the annexation of an area known as South 124th Street to Rainier Vista Sewer District was filed with the County Council effective August 6, 1979.
- 2. Rainier Vista Sewer District has found the petition for annexation to be sufficient and has, by Resolution 308, concurred with the proposed annexation.
- Rainier Vista Sewer District filed a Declaration of Nonsignificant Impact dated April, 1977, on the proposed annexation.
- The County Council held a public hearing on the \_\_\_\_, 19\_\_\_, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION\_1. The annexation by Rainier Vista Sewer District of the area known as South 124th Street and described in Section 2 herein is approved.

Beginning at the intersection of the south margin of South 120th Street and the centerline of Block 1, Stimson Park Division No. 1 according to the Plat recorded in Volume 25 of Plats, page 41, records of King County, Washington;

Thence west along said south margin to the centerline of Block 4 of said Stimson Park Division No. 1;

Thence south along said centerline of Block 4 to the northeast corner of Lot 45 of said Block 4;

Thence west along north line of said Lot 45 and extension thereof to the west line of the  $E\frac{1}{2}$  of the  $E\frac{1}{2}$ of the  $W_2$  of said  $SE_4$  of Section 8;

Thence south along said west line to a point 130 feet north of the south line of said Section 8;
