AN ORDINANCE granting interim approval of the Sahalee Sewer District Comprehensive Plan.

## PREAMBLE:

On September 12, 1977, Sahalee Sewer District passed Resolution No. 268 adopting and amending their comprehensive plan.

The King County Sewerage General Plan has established a local service area which may be served by the Sahalee Sewer District.

The area which Sahalee Sewer District serves (East Sammamish Plateau) is presently the subject of a Community Planning Process which may modify the existing local service area of the Sewerage General Plan.

As required by KCC 13.24, the Utilities Technical Review Committee reviewed the comprehensive plan and on August 22, 1979 recommended its interim approval.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Sahalee Sewer District Comprehensive Plan, as adopted and amended by district Resolution No. 268 (attached) is hereby granted interim approval only to the extent that the facilities provided for by the comprehensive plan are necessary to provide service to the Local Service Area established by the Sewerage General Plan. This approval shall be valid for a period not to exceed twelve months after the adoption of the East Sammamish Communities Plan by the King County Council. adoption of the East Sammamish Communities Plan, King County, through the Utilities Technical Review Committee, shall initiate a reexamination of the Sahalee Comprehensive Plan in light of the provisions of the Community Plan and the modified Local Service Area (if any). After such a reexamination, the Utilities Technical Review Committee shall make a recommendation to the County Council regarding the modification or extension of this interim approval.

SECTION 2. Any subsequent amendment to the Sahalee Sewer
