7 ORDINANCE NO. 4516

8 AN ORDINANCE amending King County Zoning
9 Resolution No. 25789, as amended, by amend-
10 ing the Zoning Map thereof reclassifying certain
11 property thereon at the request of Rodney
12 Bayles, Building and Land Development Division
13 File No. 198-78-R.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. Rodney Bayles petitioned on August 2, 1978,
16 that the property described in Section 3 below be reclassified
17 from SR to RD 3600 and this application was assigned Building
18 and Land Development Division File No. 198-78-R.

19 SECTION 2. The report and recommendation of the Building
20 and Land Development Division was transmitted to the Zoning and
21 Subdivision Examiner on October 12, 1978, and hearing was held
22 by the Examiner on the matter October 19, 1978. The report of
23 the Examiner was filed with the Clerk of the King County Council
24 on December 5, 1978, and the Council approved the reclassification
25 by Motion No. 3888 on December 11, 1978, subject to conditions
26 which have been satisfied.

27 SECTION 3. The legal description of the property to be re-
28 classified is attached as Appendix A and is hereby made a part
29 of this ordinance. The above described property is shown on the
30 attached map which is designated Appendix B and is hereby made
31 a part of this ordinance.

32 SECTION 4. The King County Council does hereby amend King
33 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
fying that property described and shown in Section 3, Appendices

A and B above, to RD 3600 and directs that Area Map W 29-26-5 be modified to so designate.

SECTION 5. This reclassification is granted subject to conditions adopted in Motion No. 3888 and said conditions are incorporated as though fully set forth herein.
