

ORDINANCE NO. 4550

AN ORDINANCE relating to the annexation of an area known as Nelson to King County Water District No. 90.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Nelson to King County Water District No. 90 was filed with the County Council effective September 27, 1979.

2. King County Water District No. 90 has found the petition for annexation to be sufficient and has, by Resolution 345, concurred with the proposed annexation.

3. King County Water District No. 90 filed a Declaration of Nonsignificant Impact dated July 17, 1978, on the proposed annexation.

4. The County held a public hearing on the 29~~th~~ day of October, 1979, and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 90 of the area known as Nelson and described in Section 2 herein is approved.

SECTION 2. The area known as Nelson to be annexed is described as follows:

Beginning at the Northwest corner of the East 1/2 of the West 1/2 of the West 1/2 of the NW 1/4 of Section 2, Township 23 North, Range 5 East, W.M.;

Thence Easterly along the North line of the said NW 1/4 to the Northeast corner thereof;

Thence Southerly along the East line of the said NW 1/4 to its intersection with centerline of the New Castle Hobart County Road right of way;

Thence Southeasterly along said centerline to its intersection with a line which bears North 39°00'45" East from a point on the Northeasterly boundary of Block "C", of May Valley Division No. 2, according to plat thereof recorded in Volume 38 of Plats, page 47, records of King County, Washington; said point being South 55°07'36" East 327.07 feet from the most Northerly corner of Lot 12, Block "C";

1 Thence South 39°00'45" West to the said Northeasterly
2 boundary of Block "C";

3 Thence North 55°07'36" West along said Northeasterly
4 boundary to its intersection with the North line of the
5 Sount 1/2 of said Section 2;

6 Thence Westerly along said North line to its
7 intersection with the Northeasterly boundary of Lots 8
8 and 9, said Block "C";

9 Thence Northwesterly along siad Northeasterly boundary
10 and the Northeasterly boundary of Block "B", said May
11 Valley Division No. 2, to its intersection with the
12 South line of the said NW 1/4 of Section 2;

13 Thence Westerly along siad South line to its
14 intersection with the West line of the East 1/2 of the
15 West 1/2 of the West 1/2 of the said NW 1/4

16 Thence Northerly along said West line to its
17 intersection with the North line of the said NW 1/4 and
18 the Point of Beginning.
