ORDINANCE NO.

AN ORDINANCE amending King County Zoning Code, Resolution No. 25789, as amended, by amending the Zoning Map thereof adopting a Final Planned Unit Development on certain property thereon at the request of Galaxy Investment Corp., Building and Land Development Division File No. 242-76-P.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
