10 ORDINANCE NO. 4584

11 AN ORDINANCE amending King County Zoning Resolu-
12 tion No. 25789, as amended, by amending the Zoning
13 Map thereof reclassifying certain property thereon
at the request of Alex T. Klouzal, Building and Land
Development Division File No. 270-78-R.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. Alex T. Klouzal petitioned on April 6, 1978, that
16 the property described in Section 3 below be reclassified from
17 SR to RM 900 and this application was assigned Building and Land
18 Development Division File No. 270-78-R.

19 SECTION 2. The report and recommendation of the Building
20 and Land Development Division was transmitted to the Zoning
21 and Subdivision Examiner on July 20, 1978 and March 27, 1979,
22 and hearings were held by the Examiner on the matter February 6,
23 1979 and March 27, 1979. The report of the Examiner was filed
24 with the Clerk of the King County Council on May 24, 1979,
25 and the Council approved the reclassification by Motion No.
26 4283 on May 29, 1979, subject to conditions which will be satis-
27 fied per the "P" suffix.

28 SECTION 3. The legal description of the property to be
29 reclassified is attached as Appendix A and is hereby made a
30 part of this ordinance. The above described property is
31 shown on the attached map which is designated Appendix B and
32 is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A and B above, to RM 900-P and directs that Area Map W 8-21-4 be modified to so designate.

SECTION 5. This reclassification is granted subject to conditions adopted in Motion No. 4283 and said conditions are incorporated herein as though fully set forth herein.
