ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Robert C. Bockoven, M.D. Building and Land Development Division File No. 400-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Robert C. Bockoven, M.D., petitioned on July 3, 1978, that the property described in Section 3 below be reclassified from SR to RM 900 and this application was assigned Building and Land Development Division File No. 400-78-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on October 19, 1978, and hearing was held by the Examiner on the matter October 26, 1978. The report of the Examiner was filed with the Clerk of the King County Council on March 8, 1979, and the Council approved the reclassification by Motion No. 4270 on May 29, 1979, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
