9 ORDINANCE NO. 4589

10 AN ORDINANCE amending King County Zoning Resolu-  
11 tion No. 25789, as amended, by amending the Zoning  
12 Map thereof reclassifying certain property thereon  
at the request of Mary E. Banks, Building and Land  
Development Division File No. 230-79-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Mary E. Banks petitioned on January 24, 1979,  
15 that the property described in Section 3 below be reclassified  
16 from RS 7200 (Potential RM 900) to RM 900 and this application  
17 was assigned Building and Land Development Division File No.  
18 230-79-R.

19 SECTION 2. The report and recommendation of the Building  
20 and Land Development division was transmitted to the Zoning  
21 and Subdivision Examiner on May 24, 1979, and hearing was  
22 held by the Examiner on the matter May 31, 1979. The report  
23 of the Examiner was filed with the Clerk of the King County  
24 Council on June 22, 1979, and the Council approved the re-  
25 classification by Motion No. 4350 on July 2, 1979, subject to  
26 conditions which will be satisfied per the "P" suffix.

27 SECTION 3. The legal description of the property to be  
28 reclassified is attached as Appendix A and is hereby made a  
29 part of this ordinance. The above described property is  
30 shown on the attached map which is designated Appendix B and  
31 is hereby made a part of this ordinance.

32 SECTION 4. The King County Council does hereby amend  
33 King County Zoning Code, Resolution No. 25789, as amended,

1 by reclassifying that property described and shown in  
2 Section 3, Appendices A and B above, to RM 900-P and directs that  
3 Area Map E 28-22-4 be modified to so designate.

4 SECTION 5. This reclassification is granted subject to  
5 conditions adopted in Motion No. 4350 and said conditions are  
6 incorporated herein as though fully set forth herein.

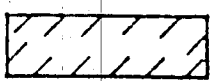
