AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of E. R. Bartholomew, et al, Building and Land Development Division File No. 262-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
