9 ORDINANCE NO. 4650

10 AN ORDINANCE amending King County Zoning Reso-
11 lution No. 25789, as amended, by amending the
12 Zoning Map thereof reclassifying certain property
thereon at the request of Lorene Buhrman, Build-
and Land Development Division File No. 266-79-R.

13 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

14 SECTION 1. Lorene Buhrman petitioned on May 7, 1979, that
15 the property described in Section 3 below be reclassified from
16 RS 7200 (Potential RM 1800) to RM 1800 and this application was
17 assigned Building and Land Development Division File No. 266-79-R.

18 SECTION 2. The report and recommendation of the Building and
19 Land Development Division was transmitted to the Zoning and Sub-
20 division Examiner on July 19, 1979, and hearing was held by the
21 Examiner on the matter July 26, 1979. The report of the Examiner
22 was filed with the Clerk of the King County Council on August 23,
23 1979, and the Council approved the reclassification by Motion No.
24 4469 on August 27, 1979, subject to conditions which will be satis-
25 fied per the "P" suffix.

26 SECTION 3. The legal description of the property to be re-
27 classified is attached as Appendix A and is hereby made a part of
28 this ordinance. The above described property is shown on the at-
29 tached map which is designated Appendix B and is hereby made a
30 part of this ordinance.

31 SECTION 4. The King County Council does hereby amend the King
32 County Zoning Code, Resolution No. 25789, as amended, by reclassi-
33

1 fying that property described and shown in Section 3, Appendices
2 A and B above, to RM 1800-P and directs that Area Map W 15-23-4 be
3 modified to so designate.

4 SECTION 5. This reclassification is granted subject to con-
5 ditions adopted in Motion No. 4469 and said conditions are incor-
6 porated herein as though fully set forth herein.
