## ORDINANCE NO.

AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Lenora Sannes, et al, Building and Land Development Division File No. 240-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Lenora Sannes, et al, petitioned on February 28, 1979, that the property described in Section 3 below be reclassified from RS 7200 (Potential RM 2400) to RM 1800 and this application was assigned Building and Land Development Division File No. 240-79-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on April 19, 1979, and hearing was held by the Examiner on the matter April 26, 1979. The report of the Examiner was filed with the Clerk of the King County Council on August 9, 1979, and the Council approved the reclassification by Motion No. 4451 on August 27, 1979, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

OVERALL LEGAL DESCRIPTION:
