- 1. A petition has been filed requesting vacation of a portion of Southeast 36th Street (Frontage Road), hereinafter described.
- The Division of Building and Land Development has studied the proposed road vacation and finds that it would not be in conflict with the principles and purposes of the King County Comprehensive Plan and the specific plans in the vicinity of this proposed vacation.
- 3. The Department of Public Works notified the various utilities serving the area and was advised that an easement has been secured by Puget Sound Power and Light Company.
- 4. The vacation area, totaling approximately 30,600 square feet, was acquired by public funds. A search of the records indicates that the County has spent no funds for construction or maintenance of the subject area. The vacation area is classified "Class A," in accordance with Ordinance No. 2759. King County is now in receipt of \$12,603.00 from the petitioner which has been judged to be the just compensation to King County for this vacation area.
- 5. The Department of Public Works considers the subject vacation area useless as part of the County road system and believes that the public would be benefited by the return of this unused area to the public tax rolls.

Due notice was given in the manner provided by law and a hearing was held by the King County Council on the 4th day of January, 1980.

In consideration of the benefits to be derived from the subject vacation, the Council has determined that it is in the best interest of the citizens of King County to grant said petition.
