AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Donald A. Dean, Building and Land Development Division File No. 213-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

Donald A. Dean petitioned on December 6, 1978, that the property described in Section 3 below be reclassified from RS 7200 (Potential RM 1800) to RM 1800 and this application was assigned Building and Land Development Division File No. 213-79-R.
