AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Kenneth T. Williams, Building and Land Development Division File No. 227-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Kenneth T. Williams petitioned on January 23, 1979, that the property described in Section 3 below be reclassified from C-G to RD 3600 to C-G and this application was assigned Building and Land Development Division File No. 227-79-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on the matter March 15, 1979, and hearings were held by the Examiner on the matter March 22, 1979 and August 7, 1979. The report of the Examiner was filed with the Clerk of the King County Council on September 13, 1979, and the Council approved the reclassification by Motion No. 4502 on September 17, 1979, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

OVERALL LEGAL DESCRIPTION:

That portion of Section 12-23-4 E.W.M. described as follows:

West 108 feet of east 354 feet of Southwest quarter of Northwest quarter lying north of Renton Avenue and south of S. 116th Pl., less portion within the following: Beginning at intersection of West line of East 246 feet of said subdivision and the North line of Renton Avenue; thence Northerly along said West line 153 feet; thence Westerly at right angles 154 feet; thence Southerly parallel with said West line 132.7 feet to the North line of said Avenue; thence Southeasterly along said North line to point of beginning.

Except the North 67 feet thereof as measured at right angles along the east line of said portion.
