AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Violet Brehm, et al., Building and Land Development Division File No. 166-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Violet Brehm, et al. petitioned on April 30, 1979, that the property described in Section 3 below be reclassified from RS 9600 (Potential RM 2400) to RM 1800 and this application was assigned Building and Land Development Division File No. 166-79-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on August 2, 1979, and hearing was held by the Examiner on the matter August 9, 1979. The report of the Examiner was filed with the Clerk of the King County Council on September 6, 1979, and the Council approved the reclassification by Motion No. 4484 on September 10, 1979, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

SECTION 4. The King County Council does hereby amend King County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices
