AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Maximilian Group, Building and Land Development Division File No. 168-79-R.

The report of the Examiner was filed with the Clerk of the King County Council on September 13, 1979, and the Council approved the reclassification by Motion No. 4503 on September 17, 1979, subject to conditions which will be satisfied per the "P" suffix.
