AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Property Investment Service, Inc., Building and Land Development Division File No. 160-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Property Investment Service, Inc. petitioned on April 17, 1979, that the property described in Section 3 below be reclassified from BN and SR to RM 2400-P and this application was assigned Building and Land Development Division File No. 160-79-R.

The report and recommendation of the Building and SECTION 2. Land Development Division was transmitted to the Zoning and Subdivision Examiner on July 5, 1979, and hearings were held by the Examiner on the matter July 12, 1979 and August 28, 1979. The report of the Examiner was filed with the Clerk of the King County Council on October 23, 1979, and the Council approved the reclassification by Motion No. 4579 on October 29, 1979, subject to conditions which will be satisfied per the "P" suffix.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
