

ORDINANCE NO. 4758

AN ORDINANCE relating to the annexation of an area known as Ruth to King County Water District No. 58.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Ruth to King County Water District was filed with the County Council effective December 27, 1979.

2. King County Water District No. 58 has found the petition for annexation to be sufficient and has, by Resolution 1856, concurred with the proposed annexation.

3. King County Water District No. 58 filed a Declaration of Nonsignificant Impact dated November 27, 1979, on the proposed annexation.

4. The County Council held a public hearing on the 3rd day of March, 1980, and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 58 of the area known as Ruth and described in Section 3 herein is approved.

SECTION 2. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

SECTION 3. The area known as Ruth to be annexed is described as follows:

Beginning at the Northwest corner of the Southwest quarter of the Southeast quarter of Section 3, Township 22 North, Range 5 East, W.M., in King County, Washington; said point lies on the existing boundary of Water District No. 58;

Thence Easterly along the North line of said Southwest quarter to the West line of the East half of the West half of the Southwest quarter of said Southeast quarter;

Thence Southerly along said West line to the South line of said Section 3;

1 Thence Westerly along said South line to the South
2 quarter corner of said Section 3, also being the North
3 quarter corner of Section 10, Township 22 North, Range
4 5 East, W.M., in King County, Washington;

5 Thence Southerly along the East line of the Northwest
6 quarter of said Section 10, a distance of 180 feet;

7 Thence Westerly along a line which lies 180 feet South
8 of and parallel to the North line of said Northwest
9 quarter to an intersection with a line parallel to and
10 270 feet East of the West line of the Northeast quarter
11 of said Northwest quarter;

12 Thence North along said parallel line to the North line
13 of said Northwest quarter, also being the South line of
14 the Southwest quarter of Section 3, Township 22 North,
15 Range 5 East, W.M.;

16 Thence Easterly along the South line of said Southwest
17 quarter to the West line of the East 866 feet thereof;
18 said point being on the Easterly line of a tract of
19 land deeded to the King County Parks Department
20 recorded under Auditor's File No. 7203080443.

21 Thence Northerly along the West line of said East 886
22 feet to the North line of the Southeast quarter of the
23 Southwest quarter of said Section 3;

24 Thence Easterly along said North line to the East line
25 of said Southwest quarter and the Point of Beginning.
