Said turn around shall be built to King County standards and shall be constructed prior to the issuance of any building permits for this development. The legal description furnished on the petition has been reduced from 18,452 square feet to 13,988 square feet. The petitioner shall deed to King County additional square footage to complete the turn around. Therefore, the Division has no objection to the vacation.
- 5. The vacation area was acquired with public funds by quit claim deed in 1920 and 1921. The County has maintained the roadway for approximately thirty years. Right of way would, therefore, be Class A and B in accordance with County Ordinance No. 2759.
- 6. The revised area to be vacated is approximately 13,988 square feet. The compensation paid by the petitioner to King County in the amount of \$17,438.00 has been reduced to \$13,220.00, therefore, \$4,218.00 shall be refunded to the petitioner.
