ORDINANCE NO. 4832

AN ORDINANCE relating to the annexation of an area known as DS-25R to Des Moines Sewer District.

## STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as DS-25R to Des Moines Sewer District was filed with the County Council February 6, 1980.

2. Des Moines Sewer District has found the petition for annexation to be sufficient and has, by Resolution 1979-48, concurred with the proposed annexation.

3. Des Moines Sewer District filed a Declaration of Nonsignificant Impact dated December 19, 1979, on the proposed annexation.

4. The County Council held a public hearing on the 14th day of April, 1980, and has considered the criteria set forth in RCW 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Des Moines Sewer District of the area known as DS-25R and described in Section 2 herein is approved.

SECTION 2. The area known as DS-25R to be annexed is described as follows:

That portion of the SW 1/4 of Section 16, Township 22 North, Range 4 East, W.M., described as follows:

Beginning at the SW corner of said Section 16; thence Northerly along the West line of said Section 16 to its intersection with the North line of the South 440.50 feet of the North 1/2 of the SW 1/4 of the said SW 1/4;

1 then Easterly along said North line to its  
2 intersection with the East line of the SW 1/4  
3 of the said SW 1/4; thence Southerly along  
4 said East line to its intersection with the  
5 South line of said Section 16; thence Westerly  
6 along the South line of said Section 16 to  
7 the SW corner thereof and the Point of  
8 Beginning.

9 SECTION 3. Completion of this annexation does not consti-  
10 tute county approval or disapproval of any other permits, certi-  
11 fications, or actions necessary to provide service to this  
12 annexation area.
