AN ORDINANCE relating to the vacation of the Plat of Angle Lake Sailing Beach V-1670 Petitioner: E & B Developers, Inc. and Others

STATEMENT OF FACTS

- 1. A petition has been filed requesting vacation of the Plat of Angle Lake Sailing Beach, hereinafter described.
- 2. The Division of Building and Land Development has studied the proposed plat vacation and finds that it would not be in conflict with the principles and purposes of the King County Comprehensive Plan and the specific plans in the vicinity of this proposed vacation.
- 3. The Department of Public Works notified the various utilities serving the area and was advised that easements are not required.
- 4. Purpose of the plat vacation is to permit better utilization of the land area and formation of a Planned Unit Development, "Park View Apartments," given preliminary approval by the King County Council's Motion No. 3629. Condition No. 10 of said Motion required vacation of the plat. An area of County right of way will be vacated together with the lot lines in the plat.
- 5. The Department of Public Works considers the subject right of way useless as part of the County road system and believes the public would be benefited by the return of this unused area to the public tax rolls.

Due notice was given in the manner provided by law and a hearing was held by the King County Council on the 1440 day of 1980, 1980
