AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of ROBERT F. RABE, JR., Building and Land Development Division File No. 293-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Robert F. Rabe, Jr. petitioned on August 29, 1979, that the property described in Section 3 below be reclassified from S-R to RD-3600 and this application was assigned Building and Land Development Division File No. 293-79-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on October 18, 1979, and hearing was held by the Examiner on the matter October 25, 1979. The report of the Examiner was filed with the Clerk of the King County Council on November 26, 1979, and the Council approved the reclassification by Motion No. 4629 on December 3, 1979, subject to conditions which will be satisified per the "P" suffix.

The legal description of the property to be reclas-SECTION 3. sified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.

The King County Council does hereby amend King SECTION 4. County Zoning Code, Resolution No. 25789, as amended, by reclassifying that property described and shown in Section 3, Appendices A

and B above, to RD-3000-P and directs that Area Map E 29-23-5 be
modified to so designate.
