## ORDINANCE NO. 438

AN ORDINANCE amending King County Zoning Code, Resolution No. 25789, as amended, by amending the Zoning Map thereof adopting a Final Planned Unit Development on certain property thereon at the request of High Clydes Investments Inc., Building and Land Development Division File No. 225-78-P.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. High Clydes Investments Inc. petitioned on December 23, 1977, that the planned unit development be adopted on property described in Section 3 below and this application was assigned Building and Land Development Division File No. 225-78-P.
