AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Standard Pacific Northwest, Building and Land Development Division File No. 214-79-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Standard Pacific Northwest petitioned on December 18, 1978, that the property described in Section 3 below be reclassified from S-R to RD 3600 and this application was assigned Building and Land Development Division File No. 214-79-R.

SECTION 2. The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on March 8, 1979, and hearing was held by the Examiner on the matter March 15, 1979. The report of the Examiner was filed with the Clerk of the King County Council on March 22, 1979, and the Council approved the reclassification by Motion No. 4162 on April 16, 1979, subject to conditions.

SECTION 3. The legal description of the property to be reclassified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part of this ordinance.
