ORDINANCE NO. 4953

AN ORDINANCE approving the Kittitas County Sewer District No. 1 Snoqualmie Pass Facilities Plan.

PREAMBLE:

On February 13, 1980, Kittitas County Sewer District No. 1 passed Resolution No. 80-3 which adopted the Snoqualmie Pass Facilities Plan as an amendment to their comprehensive plan.

Kittitas County Sewer District No. 1 adopted a Declaration of Non-Significance for the proposed plan on February 13, 1980.

As required by KCC 13.24, the Utilities Technical Review Committee reviewed the proposed Facilities Plan and on April 23, 1980 recommended its approval with the following findings:

1. The proposed improvements are necessary to correct a water pollution problem caused by overloading of the present sewage treatment plan.

2. Kittitas County Sewer District No. 1 does not provide direct sewer service within King County. Instead, it contracts with King County Summit Sewer District. Summit Sewer District has not submitted a comprehensive plan to King County as required by RCW 56.08. The expansion of sewer service within King County will require the submittal of a Summit Sewer District Comprehensive Plan as well as a review of the Local Service Area established by the King County Sewerage General Plan.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Kittitas County Sewer District No. 1 Snoqualmie Pass Facilities Plan as adopted by district Resolution No. 80-3 (attached) is hereby approved. This approval does not constitute King County approval or disapproval of any other permits, certifications, or actions necessary to provide an expansion of sewer service within King County.

RESOLUTION NO. 80-3

A RESOLUTION of the Board of Sewer Commissioners of Kittitas County Sewer District No. 1, Kittitas County, Washington, adopting a facilities plan as an amendment to the comprehensive plan for a system of sewers for the District, as amended.

WHEREAS, by resolution adopted February 5, 1964, the District adopted a general comprehensive plan for a system of sewers for the District; and

WHEREAS, the District amended that comprehensive plan by providing a plan of additions to and betterments and extensions of that comprehensive plan by resolution adopted on June 13, 1967, and subsequently amended that resolution by Resolution No. 68-4 adopted on June 5, 1968; and

WHEREAS, the District further amended that comprehensive plan by providing a plan of additions to and betterments and extensions of that comprehensive plan by Resolution No. 69-3 adopted March 5, 1969; and

WHEREAS, the District further amended that comprehensive plan by providing a plan of additions to and betterments and extensions of that comprehensive plan by Resolution No. 70-18 adopted November 4, 1970; and

WHEREAS, the District further amended that comprehensive plan by providing a plan of additions to and betterments and extensions of that comprehensive plan by Resolution No. 77-1 adopted September 14, 1977; and

WHEREAS, the District is in need of improving and upgrading its sewage treatment plant and capacity for handling additional wastewater through its interceptor sewers and treatment plant and has caused a facilities plan for such improvements to be prepared by Preston L. Shepherd & Associates, Inc., of Yakima, Washington, consulting engineers for the District; and

WHEREAS, that facilities plan has been found by the Commissioners of the District to be consistent with the existing comprehensive plan and goals for the District, as amended; NOW, THEREFORE,


BE IT RESOLVED BY THE BOARD OF SEWER COMMISSIONERS OF KITTITAS COUNTY SEWER DISTRICT NO. 1, KITTITAS COUNTY, WASHINGTON, as follows:

Section 1. The Board has caused an investigation to be held under the requirements of the State Environmental Policy Act to determine the environmental impact that the proposed plan will have on the District and as a result of that investigation it is determined that the plan to be adopted by this resolution will have no significant detrimental impact on such environment.

Section 2. The facilities plan, dated December, 1979, prepared by Preston L. Shepherd & Associates, Inc., of Yakima, Washington, consulting engineers for the District, is hereby adopted as a plan of additions to and betterments and extensions of the system of sewers of the District and an amendment to the general comprehensive plan for a system of sewers of the District.

Section 3. The estimated cost of carrying out the plan of additions to and betterments and extensions of the comprehensive plan of the District adopted by this resolution is estimated to be \$1,393,800, which costs shall be paid by the proceeds of \$115,000 general obligation bonds heretofore authorized by the voters of the District, by the receipt of federal and state grants and by the issuance of sewer revenue bonds of the District to the extent necessary to pay such costs.

ADOPTED at a regular open public meeting of the Board of Sewer Commissioners of Kittitas County Sewer District No. 1, Kittitas County, Washington, this 13th day of February, 1980.


